# 2. Eligible Training Provider List

LA Workforce Commission provided a list of the recommended programs to approve, largely based on the Star Rating of the occupation for which the program trains students. The occupations with 3 or more stars were recommended for approval.

On motion by Gary Nugent, seconded by Rich Dupree, with -0- nays, -0- abstained and 19 yes votes, the Workforce Development Board approved the list of programs.

#### 3. Modifications to Policies

With information available now from USDOL and with the finalized Youth Program Operations policy and Eligible Training Provider policy from LWC, recommendation was made that two youth policies have a minor revision and the creation of an Eligible Training Provider policy.

On motion by Haywood Joiner, seconded by Susan Broussard, with -0- nays, -0- abstained and 19 yes votes, the Workforce Development Board approved the revisions and creation of policies.


